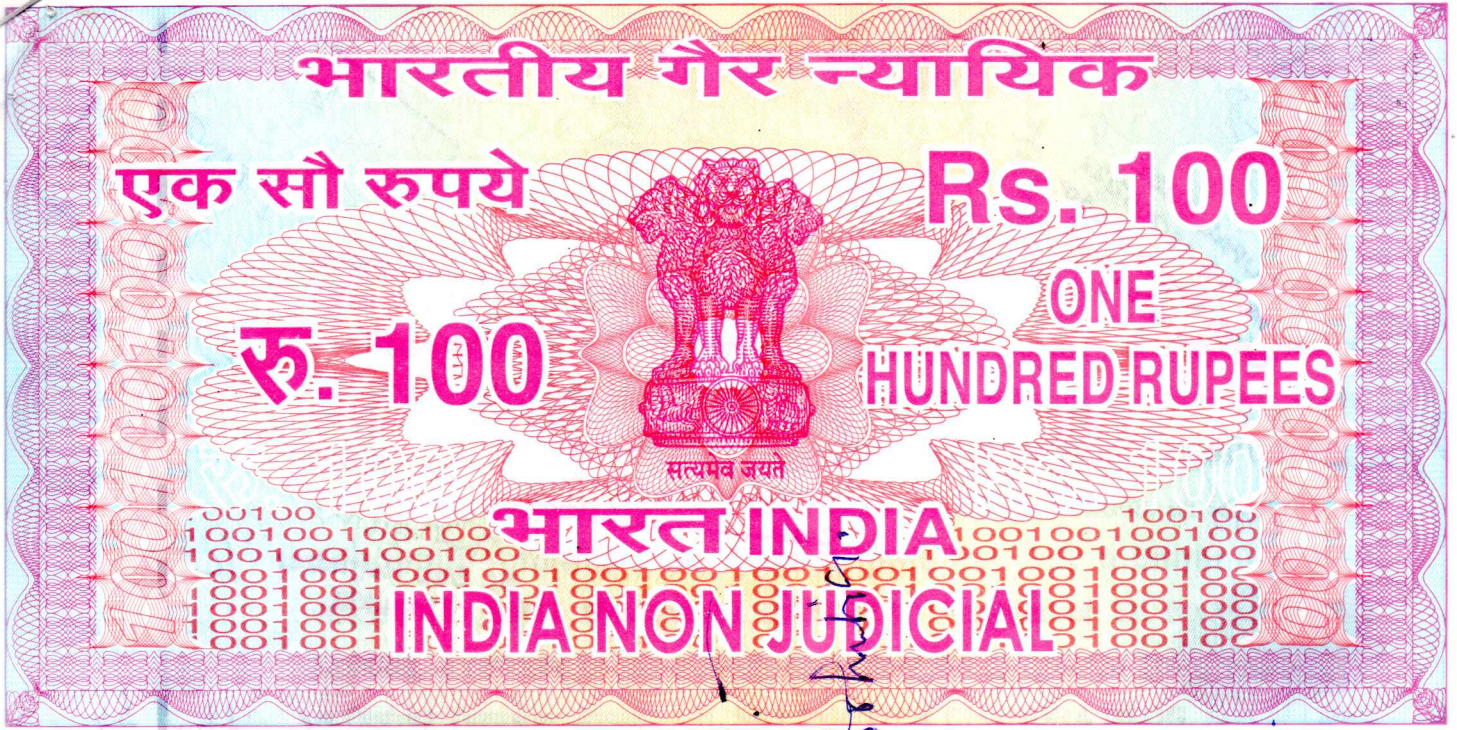

Baruah, Son of Late Nila Kanta Baruah, a resident of Bordoloi Nagar, P.o., P.s. & District Tinsukia, Assam have been expired and their names are appearing in the original Trust Deed being Deed No. 177 of Serial No. 766 dated 05.04.2013 registered before the office of the Sr. Sub Registrar, Tinsukia.

2. **AND WHEREAS**, in their place 2 persons namely (1) Sri Photick Chandra Neog, Son of Late Bhula Nath Neog, a resident of Panitola Gaon, near City Dhaba, P.O. Panitola, P.S. & District Tinsukia, Assam and (2) Sri Pradip Baruah, Son of Late Nila Kanta Boruah, (a retired Principal of Dinjoy Hazarimal Higher Secondary School) a resident of Gellapukhuri Road near Late Dr. P. K. Sarma's house, P.O., P.S. & District Tinsukia, Assam, have been inducted in place of above named expired Trustees and both inducted Trustees assented to such induction and this requires amendment of the Principal Deed thereby giving effect to the induction.
3. **AND WHEREAS**, the Party of the ONE PART and PARTIES of the SECOND PART formed a **TRUST** under the name and style of "**KHAGESWARI DAHUTIA MEMORIAL TRUST**" and to give effect to the objects of the TRUST both the parties hereto executed the Deed of Trust together and registered the same in the Office of the Sr. Sub- Registrar, Tinsukia, Assam being the Registered Deed No. 177 dated 05.04.2013 hereinafter to be known as the "**PRINCIPAL DEED OF TRUST**".
4. **AND WHEREAS**, though in the **Principal Trust Deed** it was proposed by the Trustees to open a school in the name of Dibru Valley Academy but no such school was ever run by the said Trust and finally it was decided by the Trustees to run a school named **Nalini Kanta Dahutia Senior Secondary School** have been run by the said Trust and as such the Principal Deed requires rectification/amendment immediately to effect the purpose of the Trust.
5. **AND WHEREAS**, in the meeting of the Board of Trustees held on 26.03.2022 resolution have been unanimously adopted rectifying the aforesaid mistake and inducting the said two new Trustees in place of the said expired trustees.

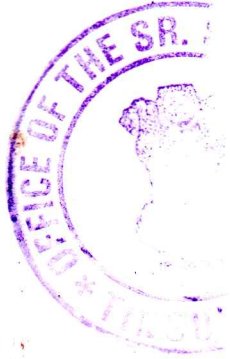
